## How long are the AMLFC Professional Certifications?

 The AMLFC Certifications are 15 – 16 weeks and classes are 2 hours 30 minutes. Candidates are expected to spend approximately 2 hours per week reading, conducting research, taking self-corrected quiz or perform other homework.

#### **Application and Admission**

To qualify for admission to the AML/CFT/FCP /CFP Certification Programs, a candidate must either complete at least one of the following in addition to a high school diploma and/or have entry level qualifications to a college/university:

- Apply online at the UCC Corporate Education webpage
- Be admitted at UCC or any Partner University Institution.
- Have obtained a least an associate degree from UCC or another accredited Institution.
- Have accumulated five (5) years of experience working for a regulated entity under AML/CFT/FCP/CFP, a regulator, an enforcement agency, or government and possess at least a high school diploma.

## Can I resume an application?

Applications must be completed in one instance. The application takes 5-10 minutes to complete.

## What does my registration include?

- The 15 weeks/15 modules course provided by
  - o Live teachers & assistant teachers online
  - Guest speakers from regulated industries, regulators, or subject matter experts
  - Access to SafetyNet with theList.pro PEP, Sanction Screening and Enhanced Due Diligence (EDD) for the duration of the course modules
  - Once a cohort is in session new registrations will not be accepted after the 2nd module
- A Proctored supervised final exam which leads to the recognized designation for the selected certification.
- Upon successful completion of the course a 1month subscription to SafetyNet with <u>theList.pro</u>
- Access to the <u>AMLFC Institute</u> private LinkedIn group
  - Access Membership platform.
  - Access to the AMLFC members private forum
  - Two (2) free webinars a year
